#### Presentations

How to Prepare for the Annual IEP Meeting from the Teacher Perspective – Erin Kassouf and Pete Schlehr

- 1. 30 days prior to meeting > data collection (input from staff/parents, progress reports, classwork, current levels)
- 2. 30-10 days prior to meeting > scheduling
- Month of meeting > draft developments (progress reports to close current IEP, begin the new IEP, review current levels, consideration of accommodations such as supports/aids, development of goals/objectives)
- 4. 5 days prior to meeting > Share the draft IEP with family
- 5. Week of meeting > Is ESY needed? Gather paperwork needed.
- 6. IEP Meeting time!
- 7. Within 5 days after meeting > update changes to draft IEP, finalize the PWN (prior written notice), send to parents

### Q&A

- Q. What do you accept as Parental Input? A Word doc or do you have a form to complete?
- A. HCPS accepts parent input in any way that the parent is comfortable providing. We do have a form that can be sent home. Parents also sometimes provide written input in a Word document or verbal input prior to or during the meeting.
- Q. How often does a student receive a psychological assessment?
- A. There is no rule as to how often a psychological assessment is administered. The IEP team is required to consider reevaluation at least every 3 years. At that meeting, the IEP team decides if updated assessments, including a psychological, are needed. As a parent/guardian, you have the right to request that specific assessments be administered.
- Q. When should we receive the PWN after an IEP? Is there an official timeline?
- A. Yes, it should be sent within 5 business days of the IEP meeting.
- Q. Am I supposed to be getting a draft IEP with updates/changes instead?
- A. Yes.
- Q. If an IEP is amended during the year and services are added as a result of additional assessments, when is the next annual review? Is it a year after the amendment or based on the original IEP date?
- A. If it is an amendment, the annual date doesn't change.
