 - a. Prep by reviewing and reading the invitation.

- b. During the meeting, take support person, if needed.
- c. After the meeting, review the prior written notice and know who to contact.
- II. Preparing for Transition Shannon Holley
 - a. Consider what academic challenges are present and develop plan.
 - b. Talk to your child about their social and emotional fears and desires.
 - c. Determine their strengths and weaknesses. Begin practicing those skills they are weak with.
 - d. Consider extracurricular activities.
 - e. Plan to attend school-based transition activities during the summer.
 - f. When transitioning to middle or high school
 - i. Review/understand the IEP.
 - ii. Study the schedule changes.
 - iii. Promote self-advocacy skills (encourage self expression, promote problem solving skills, provide opportunities).
 - iv. Establish open communication.
 - v. Provide emotional support.
